We align the interests of children, families, and child care providers to create solutions that benefit everyone. We prioritize the needs of low-income families and communities of color.

As a result of our advocacy, 13,000 more children will enroll in subsidized care this year, child care programs will be inspected annually and new funds will expand child care options for babies, toddlers, and children with disabilities.

4b (Code:) (Expenses \$ 69,814. including grants of \$) (Revenue \$) Legal Technical Assistance and Workshops: The Child Care Law Center provides legal technical assistance to legal services attorneys serving low-income clients in California. Law Center attorneys provide expertise in the areas of child care licensing, child care subsidies law, government benefits, child care for children with disabilities, child care for children in the child welfare system, and zoning and housing law affecting child care businesses.

We convene the Interagency Task Force on Child Care to remove administrative barriers to child care for very low income families. We produce "Know Your Rights" materials and video in English, Chinese and


