# YOU HELPED A MOM KEEP HER BABIES IN CHILD CARE

ary, a working mom of three, was pregnant with her fourth baby. She had successfully worked her way off welfare and she relied on a little help from the state to help pay for child care while she juggled to both raise her little ones and advance her career to provide for them. One day, she found out that she was earning \$26 a month over the maximum and no longer qualified for child care assistance.

#### Mary called Child Care Law Center in a panic.

There was no way she could afford child care for four children (at least \$2000 a month) with four mouths to feed, rent to pay, diapers to buy, gas to put in their car. Child Care Law Center's attorneys got to work right away and discovered that Mary should not be losing her child care assistance.

We defended Mary's rights. We helped her request a hearing and appeal to the California Department of Education. Thanks to you, Mary is back at work after having her fourth baby – and all of her little ones are safe and happy in child care. We could not protect families like Mary's without your support.



# YOU MADE CHILD CARE HEALTHIER FOR CALIFORNIA CHILDREN



hild Care Law Center believes that all children should be safe and healthy in child care settings. Child care presents a unique setting for the transmission of illness. Children are cared for together at a young age and before they have received scheduled immunizations or the chance to develop immunities. Maximum immunization is essential so that babies, young children and the medically compromised get protection against serious vaccine-preventable diseases.

When the opportunity arose to strengthen vaccination requirements in child care settings, we were at the forefront of the discussion. Our staff and board formed a task force in response to California Senate Bill 277, which proposed eliminating the "personal beliefs" exemption from immunization requirements.

The task force examined the public health risks, and hashed out the legal issues - including possible First Amendment conflicts. We supported the bill, which is now law in California. Because of your support, children are now safer from disease in child care.

# YOU HELPED MAKE CHILD CARE SAFER FOR CHILDREN WITH DIABETES

ou know that diabetes is a common condition – according to the CDC, 29 million people have diabetes in the U.S. - and it is possible for diabetes to be managed without a lot of hassle. Amanda is a three-year-old with diabetes and she needs insulin to manage it every day. When Amanda was first diagnosed, her parents, Jen and Luis – who both have full time jobs - were petrified at the thought of leaving their daughter in day care. Could the child care providers give Amanda the right medication? And what if something happened to their daughter while they were at work, a thirty - minute drive away?



Sure enough, the California state licensing agency told Amanda's child care providers that state law did not permit them to administer insulin, even though in 2013, the California Supreme Court had ruled that school personnel must be allowed to administer insulin to children in schools. Amanda's child care providers contacted Child Care Law Center for help.

We requested that the licensing agency follow what the schools were doing – especially because the Americans with Disabilities Act (ADA) passed over 25 years ago. We believe that children with special needs, like Amanda, deserve to be safe in child care.

Your support means that Amanda, and children like her, will not be excluded from child care programs because Child Care Law Center was there to advocate.

# YOU PROVIDED **GREATER JOB PROTECTION** FOR PARENTS

ne-third of families with children are headed by single parents and of those with both parents in the home, most likely the parents are working. What happens when there's an emergency at the daycare? What does a single mom do? What about if a parent needs to spend time looking for a good child care arrangement for her special needs child?



Many parents in California juggle the responsibility of having children in child care and going to work each day. You helped the Child Care Law Center build a bridge to make life just a little bit easier for many California families.

SB579 allows parents to take time off for child care/school emergencies AND if they need to look around for child care or school for their children. This is a big win for California families because children will feel safer, knowing that they can rely on their parent to come get them in the event of an emergency, and parents can breathe a little easier, knowing that they are not going to lose their job if they need to care for their children.

# YOU HELPED PROTECT CHILDREN FROM **CHILD ABUSE**

ou helped us sponsor a bill that could help prevent child abuse and make children safer in child care. Currently, child care providers are the **LEAST** likely of the mandated reporters to report child abuse - yet they work with the HIGHEST **RISK** population – children age 0 to 5 – and they spend the MOST time with these children, outside of the parents.

Child Care Law Center did the research, talked to experts, got the feedback from child care providers, and developed a plan to give child care providers the tools to protect children from abuse AND create a safer child care environment. The training is already available in two languages and is free and online.
