**Asunto: Solicitud Presupuestaria Actualizado Para Las Tasas Familiares de Cuidado Infantil: \$187 millones de dólares**

Estimado Defensores de la Temprana Infancia:

La pandemia ha expuesto cómo la necesidad de cuidado infantil afecta a cada faceta de la sociedad y las desiguales repercusiones de la falta de cuidado en las mujeres y las madres negras, latinas, y asiáticas. Una de las maneras de que el estado ha mitigado el impacto es a través de la suspensión de las tasas familiares. Desde el 1 de julio de 2021, las familias de California han experimentado la estabilidad que necesitan durante un periodo sostenido de incertidumbre. Los padres han podido pagar las necesidades básicas como el alquiler, la comida, y los servicios públicos porque se les ha recibido más libertad económica para elegir cómo gastar sus ingresos.

26,578 familias se han beneficiado de la suspensión de las tasas familiares del 1 de julio de 2021 al 31 de enero de 2022.<sup>1</sup> A las familias que se les cobran tasas han ahorrado una media de \$250 dólares por mes, y cientos de familias están ahorrando casi \$600 dólares por mes. Hasta ahora, la exención de las tasas familiares ha dado a las familias trabajadores de California \$48.3 millones de dólares en todo el estado. Ha dado ingresos disponibles que crea actividad económica en su economía local.<sup>2</sup>

**En consecuencia, solicitamos \$187 millones de dólares en la presupuesta estatal del año 2022-23 para la exención de tasas familiares hasta 30 de septiembre de 2024,** según lo permitido con el plan americano del rescate de 2021, y los fondos discrecionales del bloque para el desarrollo y cuidado infantil.<sup>3</sup> También solicitamos que el acuerdo de presupuesto del estado de este año adhiera a las disposiciones descritas en el Proyecto 92 de la Asamblea (Gómez Reyes).

El cuidado infantil permite que nuestros niños prosperen, que las familias trabajen, y que nuestra economía funcione. La exención de las tasas familiares les dará alivio instantáneo a los padres, protegerá a los proveedores de cuidado infantil, y garantizará que la recuperación económica de California incluya a las mujeres negras, latinas, y asiáticas.
